



**Voluntary Recall of certain milk products
Distribution area: National, Atlantic provinces and Quebec
Bedford Plant #3702**

March 24th, 2026 – Agropur is initiating a recall of the following milk products produced at its Bedford, NS (3702) facility. This voluntary recall is being conducted following an investigation related to one reported consumer complaint. The investigation identified a potential risk of glass-like material.

No other products, formats, brands or best before dates are affected. We are in contact with the Canadian Food Inspection Agency (CFIA).
